**Items Funded by this Grant**

- Assistance for salaries of Paraeducators (*\$8,000 annual max*)
- Professional Development on Inclusive Education (*various amounts awarded*)
- Learning Materials, Technology, and Equipment needed to carry out inclusive education (*various amounts awarded*)

Please note, all grant recipients are required to submit a mid-year report documenting use of grant funds. Any changes in the way grant funds are used that deviate from descriptions outlined in the grant application must be reported to Rosewood Foundation. Mid-year report forms will be sent to grant recipient schools in January 2026 and will be due the following month.

Grants are NOT awarded for the following uses: operating expenses including rent payments, lease payments, utilities, debt incurred, or purchases made prior to Rosewood award notification, travel expenses, participation in capital campaigns or projects, endowment funds, and tuition assistance.
