Items Funded by this Grant (Select One Option)

- Professional development for school staff on inclusive education practices.** Schools may submit a request to work with Inclusion Solutions LLC or another reputable program on implementing professional development that addresses their specific needs.
- A full circle review on the status of inclusive education practices at your school, along with a suggested action plan and follow-up consultation.** This service is provided by a professional inclusive education consultant and will provide feedback on how your school's learning environment aligns with your inclusive education goals.
- A stipend for one educator from your school to use for enrollment in the Foundations for Inclusive Education course through the Program for Inclusive Education at the University of Notre Dame.** This course is fully online and runs from August - December.

Please note, grant amounts may vary depending on available funds and the number of schools requesting funding. All grant recipients are required to submit a mid-year report documenting outcomes from any grants awarded.
